Finally, as a Montessori International parent, I would like to make just one more comment. I have been blessed with "two families"— an older son now in his mid-20s and two children now in first and second grade. 

I will ask Patricia not to talk to her again. I shall not trust her or Edgar again until they come into the Teachings again and then I would like to be the first one to welcome them at the gates of Camelot.

I brought my daughter to Southern California and bought a condominium, even offering to give it to her, which I did not do, just to see that her sould was protected by being near Camelot. I got her a job at Excalibur Video Systems, which involved her with people in the Teachings and with the Masters. The two girls she first lived with had the opposite reaction. The Masters with my daily calls which never stopped for six years have brought her into their circle of protection, and I am most grateful.

I had the financial burden of securing approximately \$4,000 per month without income to defray this loss for my current obligations. This went on for ten months while I gave the Church a full commitment of all my time, doing

architecture for Camelot, without taking any jobs or making money from architecture outside of Camelot. This was financially a sinking, depleting experience for me. I came to Camelot at your request to do architecture and was asked to come on my terms. My terms were obvious and you agreed to pay all my expenses. I agreed to sell my home as soon as pessible to reduce those monthly expenses and close down my business in San Francisco and devote all my time to architecture for the Ascended Masters. However, I had to make numerous trips to San Francisco to finish jobs in process and close down my business. While working for you from January 8, 1979, to November 1, 1979 I had the opportunity of working on the following jobs:

3300 seat auditorium
Will of God Focus
Montesscri International School
private residence
guard gatehouse with medal which you never saw
dining room remodel
riding academy
botique at the swimming pool
tower room for private office
numerous consultations and from 12 to 20 hours a week,
since November 1, 1979.

Since November 1, 1979, when on my own, I have gotten one job from about \$190.00 worth of ads in several local newspapers and the rest from-former clients with the help of the Ascended Masters. I have done fourteen Great Divine Director calls daily since January 1, 1980 until the present for the solving of my problems. These are jobs I have done the last five and one half months:

a 24 teenage girl home in California City (completed for a Los Angeles client)
Motel Santa Cruz (20 rooms) (I got permit)
remodel residence in San Rafael (completed in Marin County Frank Lloyd Wright Center for a permit)
duplex in San Francisco (just completed preliminaries)
store fronts (designed by Alexander Reichhardt - I pay all Camelot help \$10.00 per hour for their helping me with my jobs)
Peter Middendorf residence remodel (completed)

Because I dropped my advertising and listing in the San Francisco phone directory and discontinued my dictaphone. I had no new clients to draw from. The Masters have been good to me to let me get the job I got so far. I will be in the new San Francisco phone book as of September this year and local phone books in a few months. Peter Middendorf has remodeled a room for an office for me and when I am in San Francisco he lets me keep a phone there with an answering device. I pay him only \$50.00 a month for this service.

We did not know of 'eminent domain' and I did not know it would take so long to sell my home so I burned all my bridges behind me. This August I will be 59 years old and I have to see that I have some financial security for myself and for my daughter whom I will spensor for all of her cellege education:

This experience at Camelot has taught me to turn to the Masters always but also to be practical and look out for my own future, age and all considered. Also, I am hoping that in eight years we will get the Golden Age started and I might slow down just a little.

I must exercise my free will to own property, to sponsor my daughter and provide for my old age and the eventuality you would not need me at Camelet or if I became ill and could not work. I do not want to be a burden on the community of Camelot, nor do I expect you to provide for me if I were ill, nor to educate my daughter.

My home has been sold to Arden Van Upp for \$199.500.00.

I am receiving \$46,020.00 new and \$3.926.99 on or before
June 15. 1980. This is the down payment on my home. She
is carrying my first mortgage with World Savings for
\$84,000.00 at 9½% interest, a second mortgage of \$28.000.00
at 18% with 10 points for securing the loan and I am giving
her a third mortgage from me at 10% interest paid monthly. (65.000 loan)
This will be due to me in full in 2 years. She bought it
as a gift for her 22 year old daughter, Tammy. They both
will be down to visit Camelot next month. I am trying to
talk her daughter into going to a quarter at Summit University.
I have known Arden for about twenty years. We have renewed
our friendship of late. She also came with Linda and me
to the Washington, D.C. conference and liked it but made no
commitments.

Enclosed is a flyer on my home listed as document "A". In it you will see my home was first listed for \$260,000.00, then reduced to \$240,000.00 - then to \$199,500.00. I felt I would get \$240,000.00 for it and it was on this basis that I felt I could pay you back for all the money you gave me to meet my financial obligations. I also appreciated the fact that you would ask me to do architecture with you and the Ascended Masters. In the last 4½ months with income from architecture only I could not provide for my bills so I had to borrow \$9,600.00 from Dr. Elizabeth Moyer at 10% interest. This paid for two months of bills and I have made enough to support 2½ months of bills. I now have the following immediate bills to pay:

\$29,000.00 - current bills due now

26,500.00 - Marjorie Zeila Mull loan to buy Westlake

. condominium - due now

15.000.00 - capital gains due next April 15, 1981

9.916.50 - Dr. Elizabeth Moyer - due now

\$80.416.50

I will still have my Westlake condominium mortgage of \$51.735.00 with a \$448.00 monthly payment. I will not have to pay the \$15.000.00 capital gains until next April. I will also not pay my ex-wife the \$26.500.00, so this would give me \$10.900.00 which I would like to give to you now as full settlement of all commitments we have made to each other to date. I cannot afford to give you the \$37.431.40 which I would have done if the property had sold at \$240.000.00 but as it is I would lose all my properties if I kept this commitment. So I now will have to ask for my terms to be honored as you agreed initially, and offer the \$10.000.00 as a full settlement of all commitments to date without any future payments on said commitments. I cannot bear the burden or take on any further financial obligations any longer.

The sale of my property has not created profit for me but has been an exchange of bills yet to be paid. I can give you \$7.000.00 immediately and \$3.000.00 June 15, 1980, from the \$2,900.00 commitment from Arden Van Upp due then. Monroe wanted to salary me when we had our discussion in Edward Francis' office and was concerned I would feel I was thrown out when no longer need to do architecture here, which was a prediction of Kathleen's.

This I do not feel but I ask for you to make that financial commitment null and void by calling it salary, or independent contractor payment or a forgiveness of debt. Also, they did not want to loan me anymore money. This I understand so I sought it elsewhere. This was a very low period for me psychologically. Anyway in two years I should be in much better shape financially but I do not want any additional burdens of debt or commitment to pay debts in the future except thost that I must accept.

In the future it will take only \$945.67 a month with income from interest on the third mortgage and subletting the condominium for me to break even. This is a great relief for me. I hope to make the \$30,000.00 to pay the \$80,416.00 current debt in the next two years, as well as pay current and ongoing bills. After two years I will be in a better position to serve the Ascended Masters but I will have some time now I can give to Camelot when my jobs are not incoming from the outside work. If you can pay my \$945.62 a month expenses I will serve you full time with Architecture. If Camelot is sold I will be able to let you

claim many times over that you have paid so far for my services. I also have never billed you for gasoline or car or other operating expenses, which I have had since I have been here at Camelot. Most architects would charge you 7% commission. With thirty million dollars of buildings it would cost you over two million dollars for architectural fees. My expenses would be less than \$12,000 per year and in three years 30 million dollars of architectural work could be designed which would only cost less than \$36,000 for an architect.

Linda's mother was opposed to Linda's going to Summit University and for becoming a part of our church after all the talks Kathleen had with her. I am hoping she will change her mind and help us with her education, which would be a burden off me. She has even threatened to disinherit her. Linda will be able to help her mother as her mother does love her.

I have attended twenty conferences in a row and Linda nineteen which always kept me in debt but it was a good investment. I have paid for eight quarters for people to attend Summit. I attended two myself. I once increased my San Francisco mortgage to give to you \$3,300. I have kept a close relationship with Peter Middendorf who has given \$10,000 or so to date for Montessori International. He wants to increase it when he gets better control of the foundation. Also, he wants to visit Camelot in June. I gave him a round trip ticket for a Christmas present and do many things for him to show my appreciation for his giving to us every year. We should do something VIP for him as well as Arden Van Upp when they come to visit. I would like to bring them into the Teachings. I also managed to be a fund raiser for you, which I never thought I could do. I solicited \$2,200 from the Archangel Michael quarter for the Will of God Focus and \$3,300 from a recent Summit University graduate for the stations of the cross for the Will of God Focus. It also seems that I am tied to the Will of God Focus as the Jesus statue found me and I felt in my heart that statue was meant for you even if my photos did not give the best impression.

Dr. Moyer, Evelyn and Edgar Ford and Robert Brock were guests at my Westlake condominium at the last conference. Robert wants to come back into the Teachings and honor his \$10,000 pledge.

Peter Middendorf personally paid for David Passeger's quarter from his own money and David is applying to teach Tatiana Russian as well as Montessori and translate our books into Russian. David is a good friend of mine and I have helped him all I could to make it with my decrees and friendship since he first became interested in the Teachings.

I am prepared to give you \$10,000.00 as my total payment to you but all commitments in the past will have to be waived.

Attached is also a dictation from Sanat Kumara on architecture. My heart's desire is with Him for the new age architecture which is long overdue. I visualize octagonal glass or crystal prisms in different sizes that can be epoxied together vertically or horizontally to be a new building form, letting light and heat penetrate our buildings and with sun screens or draperies on the inside to cut out heat or light if needed. I hope and pray we can start on this or any other new age concept soon.

With all best wishes and appreciation for what you are doing for the Masters, Camelot and the planet.

I am aware of you having Edward Francis and Tom Miller interrogate Peter Scott at his office for about twenty-five minutes within two days after he came to our home for dinner. It seems you thought you could make any kind of terms with me initially to get me on staff and then take me, and by getting me to become permanent staff, then I would automatically have to sign everything over to you that I owned. I was a community member with you for one year and five months - being over six years serving you and becoming a personal friend. It is so painful to see you as you really are, no wonder one of your staff almost completed his suicide, that Monroe Shearer told me of, they are so implanted with fear and exposure, belittlement they don't dare leave. You either resolve this, I warn you, or you will have one of the biggest enemies you have yet had out to expose you.

The original of this letter, as well as copies of tapes and other information is in the hands of my attorney to be opened and used against you if anything should happen to me by any actions contemplated or implemented by you.

You can either settle this once and for all and we can get on with our lives or suffer the consequences. You now are thoroughly and completely warned, you had better not send your henchmen out to play detective again or telling people I borrowed money from you and didn't pay it back. Don't forget your evil tactics of brainwashing me, your original promises to me which you never intended to keep. You are a taker but want to appear as a giver. You so well fool the elect sons and daughters and children of God. How many times have I heard you say: "What am I going to get out of this, what are they going to give me?" You never give something for nothing.

This organization has had conferences every three months with thousands of people in attendance, and for almost the last two years has not had a permit from the regional planning director to erect a tent. A permit can be granted for a seven day period twice a year, but not four times a year. Because of past violations, no permit should be issued at this time for the New Year's Conference or for future times to make up for this gross illegality. They tried to hide the tents among the trees and hoped this would not be seen. A couple years ago, when I was on staff, the fire marshall came by and told them to take out the blower heaters as they were a fire hazard. They took them out, then after his inspection they were put right back in. This organization has become a law unto itself, disregarding codes and rules of public safety.

Immediate action should be taken to close down the Summit University classroom in the Church of the Holy Grail building because many walls were removed and no structural engineer was consulted for earthquake safety for doing same.

This room houses approximately 180 people for the conference and serves as a Summit University classroom. It should not be used for this New Year's Conference.

I designed an enclosure of an existing space at the swimming pool known as a boutique and bookstore. Window sizes were designed off the floor to conform to code. My plans were not followed. The windows were put approximately 10" off the floor and I had no verification that they are tempered glass. Verification should be made of these before the public be permitted in this area.

Stairs were built to the tower room office on the third floor level going from the second floor living quarters of Elizabeth Clare Prophet to this one tower room which is her private office. The building is known as the old Gillette Mansion. Windows also were put in that room without a permit.

The dining room at the Novitiate building consists of adjoining tents year round with a space heater. This should be investigated as a fire hazard as it adjoins the small children's classrooms.

Air conditioning and electrical work has been put throughout all ouildings without a permit. Walls have been removed and added at will.

The stable building and carriage house were made into offices and classrooms with new window walls added, without a permit.

People are living in trailers yearlong and at conferences. When I was on staff, it was Patty and Kelly Thompson, Steven Trueblood, Mr. and Mrs. Brailsford, Orla the printer, etc.

I was asked to design an elementary and high school for 525 children. I designed one where only one small oak tree could be transplanted. I was forced to design one where 17 oak trees had to be removed, and were removed. The ecology people should see that this practice cease at once.

Crowded conditions for housing exist. People sleep with the goats in the goat barn, on roofs at conferences, fourty to sixty people crowded in one room, in boiler rooms, on the floor by desks, on supply room shelves, etc. Once an inspection was made and beds were removed; people headed for the hills until after the inspection. Mrs. Prophet lives in utter luxury while her subjects suffer it out so she can get richer and more powerful.

The hay barn print operation was built in a stick type barn with just a metal roof and sides approximately four feet on the sides, otherwise completely open, with a dirt floor. This was originally designed to hold bailed hay. A complete building was constructed within this space without a permit. This was reported by someone other than myself. An architect has been employed as requested by the building inspector to verify if it is built according to code. When I saw it going up I saw that no lateral bracing was provided for, according to code, and alerted them of same. I was not on staff at that time, or at the time the Summit University classroom was made.

The gazebo, "Will of God Focus," at the Ashram of the World Mother, 3340 Country Club Drive, Los Angeles, CA 90019, on the grounds of the mansion, one of the houses of Mrs. Prophet, was drawn up by me and I got a permit. They never care if they follow my plans. They did not put foundations under the new construction, did not have air conditioning inspected, and did not provide a post under a beam. They were caught by the Los Angeles building inspector and had to follow my plans. Also the inspector asked for a post to be put under a beam, that part has not been done to this date. It should be corrected before being used any further.

You may ask, how can this happen, and rightly so. member of this cult for six years, and on staff for one year and five months as their building designer. I am licensed with the State of California Board of Architectural Examiners. I designed a thirty-three hundred seat auditorium, with a bomb shelter in the basement, preliminary drawings of a private luxury residence, with a bomb shelter under same, a riding academy, an elementary and high school, etc. No permits were secured for these because of the government's desire to claim the 220 acres of their property as a park. Under the regime of Mrs. Frophet, it is run as a strict, military-type hierarchy, where you can not question or disobey your superiors. When I tried to question, I was severely repremanded by Mrs. Prophet and her board of directors, mainly Monroe Shearer and Edward Francis. I signed a pleage to be subject to hierarchy when I joined staff, to never reveal any of their operations. For the sake of public safety, and my duty to the Board of Architectural Examiners in Sacramento, and my profession, this must be exposed. I must expose this illegality, now that I have separated myself from the cult. I am still in the process of de-programing myself from their brain washing.

I nave been threatened with death, misfortune, and I would not make my ascension from this embodiment, by Mrs. Prophet. She told me I must not provide for or educate my daugnter after the age of eighteen, she is now nineteen. That money is to go to the church instead. They disrupt marriages, separate families, and have no respect for human decency. I have undergone the painful process of de-programing myself from the guilt, fear, and condemnation that has been put upon me by their belief system. They decree (chant) against me twenty-four hours a day to try and stop me from exposing them.

This woman is one of the most clever, rip-off artists on the planet, and her followers know it not, because she claims to be Guru, messenger of the Great White Brotherhood, Vicar of Christ, (which is a claim to be Pope of the Roman Catholic Church), Nother of the Universe, and the only who is God incarnate on this planet. Actually, she seeks power, and is after money to anchor

that power.

when you know her personally, as I did, you have to accept that the end justifies the means or leave. I knew I could not continue any longer, because of her actions against me. I thank God I am no longer under her domination, or my wife, who was her private secretary for almost one year. She left before I did because she saw what was going on first hand. An expose must be done on this imposter, and it will be done.

I wish to establish their complete disregard for breaking the laws of this land, for now, on the level of their practices with doing building work.
